## CutLogic 2D End User License Agreement

---

### License

TMachines, s.r.o. (hereinafter "Author") grants you a non-exclusive, non-transferable license to use the CutLogic 2D software (hereinafter "Software") under the following terms:

The Software is available in three editions: Community, Professional, and Enterprise.

For evaluation of the Enterprise Edition, the license is limited to 30 days from the first installation of the Software. For registered Professional/Enterprise Edition, you must pay a license fee.

You may:

- For Community Edition, you may install and use a single instance of the Software by a single user on up to 3 computers.
- For each purchased Professional/Enterprise Edition workstation license, you may install and use a single instance of the Software by a single user on a single computer.
- You may use the Software in a Remote Desktop Services (RDS) environment provided that you have purchased an RDS license, which specifies the maximum number of concurrent users. The number of concurrent users accessing the Software at any given time shall not exceed the number specified in your RDS license.
- You may use the Software in a Virtual Desktop Infrastructure (VDI) environment provided that you have purchased a VDI license, which specifies the number of virtual machines. The Software may only be installed and used on the number of virtual machines specified in your VDI license.
- You may copy the Software for archival purposes, provided that each copy contains all of the original Software's proprietary notices.

You may not:

- Permit other individuals to use the Software.
- Provide the results generated by the Software to any third party as a free or paid service in any form.
- Modify, translate, reverse engineer, decompile, or disassemble the Software, except as explicitly permitted by applicable law.
- Create derivative works based on the Software.
- Copy the Software (except as specified above).
- Rent, lease, transfer or otherwise transfer rights to the Software.
- Remove any proprietary notices or labels on the Software.

### Copyright

Title, ownership rights and intellectual property rights in and to the Software remain with the Author. The Software is protected by international copyright treaties.

### Termination

The license will terminate automatically if you fail to comply with any of the terms and conditions of this Agreement. Upon termination, you must destroy all copies of the Software and all of its component parts.

## Disclaimer of Warranty

The Software is provided "AS IS", without warranty of any kind, including without limitation the warranties of merchantability, fitness for a particular purpose and non-infringement. The entire risk as to the quality and performance of the Software is borne by you. Should the Software prove defective, you and not the Author assume the entire cost of any service and repair.

## Limitation of Liability

The Author shall not be liable for any indirect, special, incidental, or consequential damages of any kind, including but not limited to damages for loss of goodwill, work stoppage, computer failure or malfunction, or any other commercial damages or losses, even if the Author has been advised of the possibility of such damages.

## Governing Law

This Agreement will be governed by and construed in accordance with the laws of Slovakia, without regard to its conflict of laws principles.

## Severability

If any provision of this Agreement is found to be invalid, illegal, or unenforceable by a court of competent jurisdiction, such provision shall be deemed severed from this Agreement and the remaining provisions shall continue in full force and effect. Invalid or unenforceable provision shall be replaced with a valid and enforceable provision that most closely reflects the original intent of the invalid or unenforceable provision.

## Entire Agreement

This Agreement constitutes the entire agreement between you and the Author regarding the Software and supersedes all prior or contemporaneous understandings, agreements, representations, and warranties, whether written or oral, relating to the Software.

By installing or using the Software, you acknowledge that you have read, understood, and agree to be bound by the terms and conditions of this Agreement.
